**James Crawford**, AC, SC (N.S.W.); D.Phil. (Oxon.); LL.D. (Cantab.); FBA. The Whewell Professor of International Law at the University of Cambridge and concurrently Research Professor of Law, Latrobe University. He was the first Australian member of the United Nations International Law Commission and in that capacity was responsible for the ILC's work on the International Criminal Court and for the second reading of the ILC Articles on State Responsibility. He was formerly Director of the Cambridge University Lauterpacht Centre for International Law. He has appeared before the International Court of Justice and other international tribunals, and is engaged as expert, counsel and arbitrator in international arbitration. In 2012, he was awarded the Hudson Medal by the American Society of International Law. He is appointed (2014) as Judge of International Court of Justice.

**Grzegorz Dziemidowicz**, MA (University of Warsaw). A former spokesman of the Ministry of Foreign Affairs. He graduated from the Oriental Institute, University of Warsaw, and completed postgraduate studies at the Institute of Journalism of the same University. He used to work at the Polish Radio as a journalist, reporter, commentator, and anchorman, and as deputy editor-in-chief at the Polish Radio and Television (1969–1991). He is a former Ambassador of the Republic of Poland to Egypt and Sudan (1994–1999), and to Greece (2001–2005). Currently, he works as a lecturer at Collegium Civitas, Warsaw, and at the Cardinal Stefan Wyszyński University.

**Rosalyn Higgins**, DBE, QC is a former Judge and President of the International Court of Justice. She graduated from Girton College, University of Cambridge, and studied at Yale Law School. Before being appointed to the Court, she was Professor of International Law at University of Kent and University of London. She also practised before English courts and international tribunals. She has received at least thirteen honorary doctorates, as well as the Yale Law School Medal of Merit and the Manley O.

Hudson Medal. In 1986, she became Queen's Counsel. She is a member of the Institut de droit international. In 1995 she became a Dame Commander of the Order of the British Empire. Dame Rosalyn is the author of numerous influential works on international law.

**Zdzisław Kędzia**, PhD (Law, Adam-Mickiewicz-University of Poznań); D.Habil. (Law, Adam-Mickiewicz-University of Poznań). Professor of Law, Chair of Constitutional Law, Faculty of Law and Administration, Adam-Mickiewicz-University of Poznań. He is also Chair of the United Nations Committee on Economic, Social and Cultural Rights, and holds the post of National Director of the European Masters Programme in Human Rights (E.MU). He is a member of the Board of the European Inter-University Centre for Human Rights and Democratization. In 1993 he was General Rapporteur of the II World Conference on Human Rights in Vienna. He is the author of many publications in the areas of constitutional law, human rights and international law.

**Bartłomiej Krzan**, PhD (Law, University of Wrocław); D.Habil. (Law, University of Wrocław). Associate Professor at the Department of International and European Law, University of Wrocław, and lecturer at the German-Polish Law School, Humboldt University Berlin. He was visiting professor at the University of Regensburg (2013), a visiting scholar at the Walther-Schücking-Institut für Internationales Recht, University of Kiel (2011–2012), and was awarded the Bohdan Winiarski Scholarship for research at the Lauterpacht Centre for International Law, University of Cambridge (2010). His fields of interest include: international responsibility, law of international organizations, international criminal law, external relations of the EU.

**Marek Prawda**, PhD (Sociol., Inst. of Phil. and Sociol., Polish Ac. Scs.). The former Ambassador to Sweden (2001–2005), and to Germany (2006–2012). In 2012 he took up his new post as Permanent Representative to the European Union. He is an economist, sociologist, and diplomat. He graduated from the University of Leipzig. He was Secretary General of the Polish-German Society. In 1980 he became member of the Solidarność movement. He is an author of various publications in the field of sociology and Polish-German relations.

**Ryszard Stemplowski**, M.Jur. (Law, University of Wrocław); PhD (Hist.) – Institute of History, Polish Academy of Science, Warsaw; D.Habil. (Hist.) – University of Warsaw, Professor of History and Political Theory, Academia Ignatianum in Kraków (since 2010), formerly at Jagiellonian University, Kraków. Research fellow of the Institute of History, Polish Academy of Sciences, Warsaw (1974–1989); Visiting Fellow at St. Antony's, Oxford

(1974). He was the recipient of a postdoctoral research grant of the Robert Bosch-Stiftung (1980–1981) and of the Alexander von Humboldt-Stiftung Fellowship (Universität zu Köln, 1981–1982), and served as the Secretary General of the Chamber of Deputies (*Szef Kancelarii Sejmu*) in the Polish Parliament (1990–1993), an Ambassador to London (1994–1999), and the first director of the new Polish Institute of International Affairs (1999–2004).
